The Society Resolves:

- 1. To formalise the system used for amending and improving the rulesof the game as follows:
- 2. The ref team may amend the rules by a majority vote amongst themselves, with a view to improving the game.
- 3. Any changes made this way take effect once conveyed to all society members and are represented as such on the website. That any such changes must be considered in play test until the next General meeting, at which point they must be brought to a vote.
- 4. The ref team should pro-actively seek the opinions and ideas of all players equally with

regard to the rules and ways to improve them.

5. A constitutional wording for this principle is to be brought to the next general meeting by Robbie."

- 1. To amend section 3.I of the constitution from
 - 3. Running of the Game
 - I. The Game shall be governed by the Game Rules, and run day-to-day by the Ref Team. The Ref team shall rule on ambiguities in the Game Rules and on the game world. Any action which alters the game world (for example, granting a character special powers or introducing an item) other than those specifically permitted by the Game Rules must be approved by the Ref Team. The Ref Team shall consist of:
 - i. A Head Ref, who shall have ultimate responsibility for the activities of the Ref Team and shall sit on the exec.
 - ii. A number of Refs, appointed by the Head Ref, who shall assist the Head Ref in the running of the Game.

To

- 3. Running of the Game
- I. The Game shall be governed by the Game Rules, and run day-to-day by the Ref Team. The Ref Team shall
- i. include a Head Ref, who shall have ultimate responsibility for the activities of the Ref Team and shall sit on the exec.
- ii. include a number of Refs, appointed by the Head Ref, who shall assist the Head Ref in the running of the Game.

- 3. The new system has been tested in play over the past year and a bit.

The Society Believes

- 1. The Geomancy system has worked well in playtest and has proven to be usable and relatively balanced.
- 2. It no longer requires editing by the ref team, and can pass into the main system rules.

The Society Resolves

- 2. To continue to keep in ref hands control over the base levels of effects (as this is often a judgement call), and the level of power in ley nexi (as this is a function of the world environment).
